

I-GUARD INTERNATIONAL PUPPY SALES AND HEALTH GUARANTEE CONTRACT



1. At the time of sale, the said puppy listed above is a healthy puppy of sound temperament. I-Guard International has done everything possible to produce healthy puppies that are free of crippling hip dysplasia, and by raising the puppies in the best way possible in regards to diet, exercise, socialization, and veterinary care.
2. Your puppy has had a complete and thorough examination by our veterinarian on this date _____, and is guaranteed to be in a good, clean state of health on departure from our premises. (This only applies to dogs that are shipped.)
3. Validation of all guarantees requires puppy be examined by a licensed veterinarian of the buyer's choice within 48 hours of puppy's arrival to buyer. This veterinary examination is mandatory to confirm that your puppy was not sick or injured at the time of delivery.
4. The buyer assumes the responsibility to continue the appropriate vaccinations, exercise, and feeding schedule as supplied by a veterinarian or as recommended by I-guard International.
5. Any puppy purchased from I-Guard International must be kept under the kennel name of I-Guard International. (For example "Rex vom I-Guard International")
6. If, for any reason, the Buyer can no longer keep the above-mentioned German Shepherd Dog, the ownership will revert to the Seller/Breeder. All AKC paperwork signed over to the Breeder/Seller must accompany the dog, plus all vet records. *No monies will be reimbursed to the Buyer. Unless agreed upon by breeder in writing.*
7. **HEALTH GUARANTEE:** I-Guard International is not responsible for any injuries once the puppy is out of its control.
8. If puppy is found to be in poor health or injured at the time of arrival to the new owner('s), buyer must provide a written statement from a licensed veterinarian stating the dog's condition. Within the 48-hour period, buyer may return the puppy to I-Guard International at buyer's expense. Buyer will receive a replacement puppy at the earliest possible time, as decided upon by I-Guard International. Regardless of circumstances, and including the 48-hour period, all vet bills are the responsibility of the buyer.
9. I-Guard International will take all precautions by administering shots and de-worming as the puppy's age allows before the puppy leaves our premises.
10. Guarantee of puppy's ears for show quality puppies — If ears are not standing by 5 months, buyer must contact I-Guard International. Buyer's vet must examine the pup at 5 months of age. The ears must be propped for a period of at least 2 weeks starting at 5 months. If ears are still not completely up at 7 months, I-Guard International will then replace the puppy if buyer so desires. A puppy with soft ears will not be replaced unless these procedures are followed and have been documented with I-Guard International.
11. If buyer returns the puppy to I-Guard International and it is found to have injuries or has been abused under the buyer's control, I-Guard International will not replace the puppy and the guarantee

is null and void. If a puppy is returned to I-Guard International, neither the deposit nor payment of the dog will be returned to the buyer.

12. All shipping costs of replacement dogs will be buyer's responsibility.

13. The buyer agrees to have the puppy Spayed/Neutered after 24 months of age.

14. The buyer agrees to keep the above said puppy on the same feeding program as the breeder has started and recommends. Eagle Pack dry dog food and the NuVet Plus supplements that the puppy has been started on. If this part of the contract is not followed, this guarantee is null and void.

15. Seller has the option to reposes a puppy if evidence is found that the puppy has been neglected and/or abused at no expense to the seller.

16. **HIP/ELBOW GUARANTEE:** The puppy is guaranteed by I- Guard International to OFA as being Excellent, Good, or Fair by 24 months of age provided the following conditions are met:

- a) Must be x-rayed and submitted to OFA for prelim evaluation between 12-14 months of age, not before and not after, and again at 24 months.
- b) The kennel requires a copy of the x-rays.
- c) The dog has not been abused or involved in any type of accident where bones are broken or bruised.
- d) The dog has been properly nourished and exercised. No jumping out of trucks, catching Frisbees in midair, etc until fully developed at 2 years of age.
- e) The dog must not be bred before 2 years of age.
- f) The dog must be kept healthy and not overweight; breeder may request photos or vet statements for proof of weight.
- g) I-Guard International has been provided with a veterinarian report of medical history and OFA report..

17. All payments and deposits made to I-Guard International are non-refundable. If the buyer decides against the purchase of the dog, the buyer may use the deposit and/or already made payments towards the purchase of another dog in the future.

18. If buyer becomes unable to take the puppy for any reason, the money paid may be applied to another puppy in a future purchase. Buyer also has the option of I-Guard International holding the puppy for up to 30 days; a boarding fee will apply.

Options for replacement/refund:

- a) Keep the puppy, and receive ½ off a replacement puppy as soon as appropriate puppy becomes available, not necessarily from the same breeding, return the puppy's AKC papers and all vet records to seller.

- b) Return puppy and receive a replacement puppy as soon as appropriate puppy becomes available, not necessarily from same breeding.

Buyer understands this contract fully and that this contract is under the jurisdiction of the State of Washington, in the County of Whitman. It is agreed the place of venue shall be in Whitman County, Washington. All and any part of this contract is null and void if any of the above criteria's have not been met in and at designated time of age.

LIMITATION OF CONTRACT

This Contract applies to the original puppy only and not transferable to a second party. All veterinary costs and shipping costs are the buyer's responsibility. No provision of this Sale Agreement may be amended without the written approval of both the Seller and the Buyer. Seller and Buyer agree to the terms set above by their signatures below.

The Buyer's signature below indicates that Buyer (s) have read, agrees, and does understand all the conditions of the Sales Agreement and Contract of Sale.
